

TOBB UND LOJISTIK YATIRIM A.S. DATA SUBJECT APPLICATION FORM AS PER LAW ON THE PROTECTION **OF PERSONAL DATA NUMBERED 6698**

In Law on the Protection of Personal Data numbered 6698 (referred to as "KVKK"), personal data owners (referred to as "Applicant"), defined as "data subject", are granted the following rights under Article 11 of KVKK:

- Learning whether your personal data is processed,
- Requesting information if your personal data has been processed,
- Learning the purpose of processing your personal data and whether they are used appropriately,
- Knowing the third parties to whom your personal data is transferred at home or abroad,
- In case your personal data is incomplete or incorrectly processed, requesting that it be corrected and requesting that the transaction carried out within this scope be notified to third parties to whom your personal data has been transferred,
- Requesting the deletion or elimination of your personal data and notifying the third parties to whom the personal data has been transferred, if the reasons requiring processing are no longer valid, although it has been processed in accordance with the provisions of other laws and other legislation related to KVKK,
- Objecting to the occurrence of a result against you by analysing the processed data exclusively through automated systems,
- Requesting compensation in case you suffer due to unlawful processing of your personal data.
